**PERRY COUNTY CONSERVATION DISTRICT (PCCD)
Erosion & Sediment Pollution Control Program Fee Schedule**

All fees must be paid at the time of the Erosion & Sediment Pollution Control (E&S) Plan submission. Major modifications to an approved Erosion & Sediment Pollution Control Plan requiring a technical review will be subject to permit and review fees. Plan review fees include planning meetings, E&S Plan reviews, construction meetings and inspections.

Depending on the project, there may be 2 different fees that must be paid upon submission:

- E&S Plan Review Fee** – made payable to “PCCD Clean Water Fund”.
- Permit Fee** – made payable to “PCCD Clean Water Fund.” If you are disturbing 1 or more acres, a permit is required.
- DEP Disturbed Acre Fee** – made payable to “Commonwealth of PA Clean Water Fund.” If a permit is required, this DEP Fee is also required; the check is forwarded to DEP by PCCD.
